

## GAMING MACHINE REFORM PACKAGE - TRADING SCHEME INFORMATION PROVIDED AS AT 1 SEPTEMBER 2023

- A scheme to allow the trading of gaming machines commenced on 31 August 2015. The scheme enables clubs to better manage their machine numbers in line with business needs.
- Through forfeitures imposed on trades and authorisations surrendered, the scheme has resulted in a reduction in the number of machine authorisations by **1229** (from **5,022** to **3,793**).
- Quarantine and storage provisions (38), together with forfeitures and surrenders (1229) and disposals (168) has resulted in a reduction of gaming machines in operation by **1435** (from **5,022** to **3,587**).
