President's Report

Dear Members

I am happy to report the Club is making good progress to withstand Covid 19 challenges. It has been a year like no other and we still have difficult times ahead but we have shown versatility and resilience and in doing so have reaffirmed the strength of our amazing Club community.

Like many hospitality based businesses we have been hit hard by the pandemic but I am confident we will be a better, stronger Club on the other side. The Board and management are determined that our venues will remain a place for members to enjoy and to feel safe and valued.

I thank CEO, Ian Mackay and all Club staff for their dedication and commitment during this difficult time.

This is my 3rd and final year as President. The last 3 years have been a period of great achievement for the Club. I look back to February this year when the Board prepared a new 5 year plan with many exciting plans and projects 'in the pipeline'. Some future plans include:

• upgrades to our Yacht Club precinct including improved car parking; and

• finalisation of a Master Plan for our Tuggeranong Venue and the adjacent Southern Cross Basketball stadium. We have already completed planned upgrades to our function spaces in Woden which include, the Top of the Cross, the Boardroom, the Private Dining Room and the Orion Room.

We are also hopeful of being able to continue to expand our health and wellness services with more locations being actively considered following on from our first NSW purchase – Anytime Jerrabomberra in late 2019.

The pandemic has been difficult but I am proud of the resilience of our staff and the support provided by our members throughout. We stayed open where and when we could, providing a service to members for dining as well as health and wellness services.

We have supported our staff, offering benefits above JobKeeper such as free meals for staff, free flu shots and, for many, payment over the JobKeeper minimum. We were also able to boost our takeaway and home delivery services, which still continue and have been very popular with Members.

We have increased support for Vinnies Night Patrol, providing free meals to those living tough on the streets – providing over 500 meals a week to the service.

Our COVID Safe plan and accompanying 'customer journey' plans have been developed painstakingly to help ensure our staff and members stay safe when visiting our Venues. It has been terrific to see the many compliments from members as to how well we have managed safety practices as restrictions have slowly eased.

Financially, the Club was on track to record a \$1m+ surplus for the year pre-Covid but with venue closures and ongoing restrictions our trading position was reversed to a \$2.1m loss for the year ended 29 June.

Happily in the last month (at the time of writing), a measure of normality has returned and it is great to see plenty of activity across the Club at all our venues and gyms.

Some major milestones were reached by our staff this year and their ongoing loyalty to the Club is something we cherish. Congratulations to the following long-serving staff members:

3 Summary of significant accounting policies

The concise financial report is an extract from the full financial report for the year ended 29 June 2020. The concise financial report has been prepared in accordance with Accounting Standard AASB 1039: *Concise Financial Reports* and the *Corporations Act 2001*.

The financial statements, specific disclosures and other information included in the concise financial report are derived from, and are consistent with, the full financial report of Canberra Southern Cross Club Limited. The concise financial report cannot be expected to provide as detailed understanding of the financial performance, financial position and financing and investing activities of Canberra Southern Cross Club as the full financial report.

Discussion and analysis of the Club's financial results are set out in the President's Report and in the analysis of Trading Results.

A copy of the full financial report and auditor's report will be sent to any member, free of charge, upon request.

The presentation used in this concise financial report is Australian dollars.

4 Going concern

The financial statements have been prepared on a going concern basis, which contemplates continuity of normal business activities and the realisation of assets and the discharge of liabilities in the normal course of business.

Due to trading restrictions caused by the COVID-19 pandemic, the Club has failed to meet one of the covenants in its lending contract resulting in an event of default. As a consequence, all bank loans amounting to \$17,116,530, have been classified as a current liability even though the termination date is October 2022. As at 29 June 2020, the club did not have an unconditional right to defer the settlement of the loans for at least twelve months after that date.

Notwithstanding the above, the directors are confident that the Club will continue as a going concern and that it is appropriate to adopt the going concern basis in the preparation of the financial report after consideration of the following factors:

- On 11 September 2020, the lender agreed to take no action in relation to the event of default.
- In addition, the lender has amended the loan covenant which will reduce the likelihood of another breach occurring in the next twelve months.
- This means the loans remain payable until 2022.



5 Events after the reporting period

The impact of the Coronavirus (COVID-19) pandemic is ongoing and while it has been financially detrimental for the company up to 29 June 2020, it is not practicable to estimate the potential impact, positive or negative, after the reporting date.

No other matter or circumstance has arisen since 29 June 2020 that has significantly affected, or may significantly affect the company's operations, the results of those operations, or the company's state of affairs in future financial years.

Community Purpose Contributions

For the period 25/6/2019 – 29/06/2020

Program Outline

A vital part of the Canberra Southern Cross Club's ethos is contributing to our community. Every year we provide support to over 350 local community groups, schools, and charities. Our goal is to demonstrate our commitment through the support of local events and activities that benefit the Canberra community as a whole. Community giving has been a central part of what the Club does since its establishment in 1972.

The Club has 5 key programs through which its community purpose contributions are distributed each year. These programs supply both cash and in-kind funding.

1. Community Key Partner Program

The Community Key Partner Program is the focus of our giving program for a three-year term. The program commenced in 2017 with the first Key Partner being Karinya House. The Key Partner receives funding in cash and in-kind support each year up to a prescribed amount as determined by the Club.

2. Community Rewards Program

The Community Rewards Program is the program that connects our members to their Community with members choosing which groups receive funding. This program is the Club's most diverse program with funding provided to schools, sporting, charitable and not-for-profit organisations.

3. Community Grants Program

The Community Grants Program provides assistance to not-for-profit organisations whose charitable work support people in Canberra and the surrounding region. The aim of the program is to provide cash funding to assist local community-based organisations which make a valuable contribution to Canberra and the region.

4. Community Welfare Program

The Community Welfare Program provides assistance to local welfare organisations whose work makes a valuable contribution to the people in Canberra and the surrounding region. At the heart of the program is the food welfare program that saw organisations such as St. Vinnies Night Patrol and the Woden Youth Centre provide over seven thousand meals last year.

5. Community Sports Program

The Community Sports Program provides assistance to sporting organisations that are affiliated with the Club, as well as to other local community-based sporting organisations. The program supports, through cash and in-kind funding, a diverse range of sports that include cricket, football, rugby union, water polo, baseball, softball, hockey, rowing and triathlon. At the centre of this program is the Club's long-standing financial support of the Canberra Yacht Club.



Community Engagement

The Canberra Southern Cross Club engages the community in several different formats. Through the Club's website, Members Magazine and social media channels, this allows the Canberra Community to be kept fully informed of our programs. Each year announcements are made on the website that applications have opened and invite online applications to be made. For existing recipients, these groups also receive direct correspondence from the Club.

Community contributions are reviewed annually (other than the 3 year Community Key Partner Program) by the Club's Community & Membership committee through a formal application process, with each applicant required to provide their mission statement, key objectives, purpose and intended use of the funding.

Community Purpose Contributions Monitoring

All of the Club's programs have clear guidelines regarding community purpose contributions and these are made available on the Club's website. Our program guidelines state all successful applications must use funds in accordance with the provisions in the *Gaming Machine Act 2004* (ACT) and the *Gaming Machine Regulations 2004* (ACT).

In addition, applications contain questions that enable the Club to form an opinion as to whether the funds are a community purpose contribution. This process allows the Club to assess each individual application and the intended positive impact the funding will have on the Canberra community.

At the end of the reporting period, recipients of funding are required to complete an acquittal confirming the total amount of funding they received and that the funding was used in accordance with the program guidelines and their application.







3. Beverage Trading 2019/20




4. Food Trading 2019/20






