

APPLICATION FOR APPROVAL OF AN ARRANGEMENT FOR THE REDISTRIBUTION OF AN UNDISBURSED JACKPOT

Gaming Machine Act 2004 s 144
Form made pursuant to s 53D of the Gambling and Racing Control Act 1999

Information

If an amount available for allocation as a prize in a linked-jackpot arrangement has not been won, and cannot be won because the approval for the arrangement has been cancelled or surrendered, a licensee may seek approval for an arrangement to redistribute the amount as a prize, or an addition to another jackpot.

If the person who held the approval for the linked-jackpot arrangement has stopped operating gaming machines or the Commission's approval has not been given for an arrangement to redistribute the amount as a prize within 4 weeks after the linked-jackpot authorisation is cancelled or surrendered then the amount is a debt owing to the Territory.

An extension of the four week period can be sought for a good reason.
